RURAL MUNICIPALITY OF LEASK NO. 464

BYLAW NO. 11 - 2021

A Bylaw of the Rural Municipality of Leask No. 464, in the Province of Saskatchewan to regulate the speed of motor vehicles.

The Council of the Rural Municipality of Leask No. 464 in the Province of Saskatchewan, in open meeting hereby enacts as follows:

- 1. In this bylaw the expression:
 - (a) "motor vehicle" shall have the meaning ascribed to it by *The Traffic Safety Act*;
 - (b) "municipal road" means a public highway or municipally owned roadway that is under the direction, management and control of the municipality;
 - (c) "provincial highway" means a public highway or a proposed public highway under the direction, management and control of the Ministry of Highways and Infrastructure;
 - (d) "public highway" shall have the meaning ascribed to it by *The Highways and Transportation Act, 1997*, but shall not include a provincial highway as designated pursuant to such Act; and
 - (e) "roadway" means that part of a public highway designed or intended for use by vehicles, but does not include a trail designated under *The Snowmobile Act* or any other trail or path for which a permit is required.
- 2. No person shall operate a motor vehicle at a greater speed than fifteen (15) kilometers per hour on that portion of a municipal road described as follows:
 - a) Through the resort area of Duncan's Beach along Duncan Drive as described on registered survey plans 02B08854.
 - b) Through the low-level crossing located on the road running through section 28-48-08 W3
- 3. No person shall operate a motor vehicle at a greater speed than twenty-five (25) kilometers per hour on that portion of a municipal road described as follows:
 - (a) Through section 3-46-8 W3
 - (b) Through the resort area of Lac La Peche as described on registered survey plan No. 87B11948
 - (c) Through the Organized Hamlet of Pelican Cove and resort area located on section 26-48-8 W3 and the grid road running north into the Hamlet of Pelican Cove to join the most east portion of Iroquois Lake Drive.
 - (d) Through the resort areas of Martin's Lake as described on registered survey plans No. 81B10323 and 84B13551
 - (e) Through the resort area of North Emerald Lake along Aspen Drive as described on registered survey plan No. 86B1226.
- 4. No person shall operate a motor vehicle at a greater speed than thirty (30) kilometers per hour on that portion of a municipal road described as follows:
 - (a) Through the resort area of Duncan's Beach along Duncan Road as described on registered survey plans 02B08854.



- (b) Across Iroquois Lake Bridge
- (c) Through the south half of section 18-47-7 W3 the Image D'amour Subdivision.
- No person shall operate a motor vehicle at a greater speed than forty (40) kilometers per hour on that portion of a municipal road described as follows:
 - (a) Through section 30-46-7 W3 from Highway 12 to Diehl Drive and Joanette Drive.
 - (b) Through sections: East 8-47-7 W3, West 4-47-7 W3, South 5-47-7 W3 to Highway 12.
- 6. No person shall operate a motor vehicle at a greater speed than fifty (50) kilometers per hour on that portion of a municipal road described as follows:
 - (a) Through section 18-46-7 W3, South Coral Road
 - (b) Through sections 13, 14 and 15-46-8 W3, South Coral Road
 - (c) On the grid road running east past the Organized Hamlet of Pelican Cove from Garand Road to the east side boundary of the Organized Hamlet of Pelican Cove.
 - (d) Through section 3-46-8 W3 along Lac La Peche Drive from Grid 783
 - (f) On the road running along the south boundary of SE-30-46-7 W3 from Highway 12 to the boundary of Martin's Lake Regional Park.
- 7. Signs indicating the maximum speed allowed shall be erected at the commencement of the speed zone area, and signs shall be erected showing the end of the speed zone area.
- 8. Any person who contravenes any of the provisions of this bylaw is guilty of an offence and liable on summary conviction to the penalties provided in the general penalty bylaw of this municipality.
- 9. Bylaw 08/2021 is hereby repealed.
