2011 Budget & Taxes

The 2011 Budget required a significant increase in the municipal mill rate as well as a proposed plan for short term borrowing of \$415,750, that will be repaid within a 3 year term.

Primary influences on the 2011 budget were:

- Road maintenance and repairs due to flooding and the high water table
- Protection of infrastructure from spring flooding
- Grid 783 Road Construction Project
- Replenishment of reserve accounts
- Accounting for the amortization of assets

Council is working to establish a 5 year capital works plan to ensure that necessary road repairs will be completed and in order of priority. If you have any questions about the 2011 budget you may contact your division councilor, the Reeve or the RM office.
