### **1.0 Purpose**

- 1.1 The purpose of this policy is to provide Administration Staff and Council with direction in regards to Council Remuneration.

### **2.0 Department(s) Affected (Scope)**

- 2.1 Department(s) Affected General Government Administration

### **3.0 Council Meetings/Council Committee Meetings/Special Meetings**

- 3.1 Council members shall be eligible for remuneration of \$25.00/hour OR when in attendance of a meeting/event(s) that exceeds 5 hours the rate of indemnity shall be \$200.00/day when representing the Rural Municipality of Leask No. 464.

#### 4.0 Travel Compensation

- 4.1 Council Members shall receive a per kilometer compensation of .60/km when attending meetings OR Inspection activities; this compensation shall be from their place of residence to the meeting location and return.

#### 5.0 Training Session, Convention

- 5.1 Council members shall be eligible for remuneration of \$200.00/day when attending Conventions and Training Sessions when representing the Rural Municipality of Leask No. 464.

#### 6.0 Accommodation/Meal Stipend

- 6.1 Council members when attending Convention/Meetings as a representative of the Municipality shall have their accommodations paid by the municipality.
- 6.2 Council members when attending Convention/Meetings as a representative of the Municipality shall receive a Stipend of up to \$90.00/day for meals, parking and gratuities. (Alcohol is not included in the stipend)

#### 7.0 Office Attendance

- 7.1 The Reeve shall be eligible for remuneration of \$1000.00/year; this shall be in recognition of signing cheques, bylaws, agreement, bank instruments, approving vouchers, etc.

#### 8.0 Road Inspection

- 8.1 Council members shall be eligible for remuneration and mileage when engaged in inspection of roads or public works to the maximum of 2 hours per week.

## 9.0 Cellar Phone Expense

- 9.1 Council members shall receive \$45.00 per month reimbursement for cellar phone use relating to municipal business.

## 10.0 Authorization of Indemnity

- 10.1 Council members shall complete their Statement of Indemnity and associated Voucher at the regular scheduled council meetings; the forms will be approved by either the Reeve or Deputy Reeve.
- 10.2 Should a member not attend the regularly scheduled Council meetings they shall submit their Statement of Indemnity and associated Voucher at the next scheduled meeting of council.
