1.0 Purpose

To regulate the issuance of Overweight Permits on Municipal Roads.

For the purpose of this policy, “Municipal Roads” shall mean all roads in the RM of Leask No. 464 except Provincial Highways.

For the purpose of this policy, “Overweight Permits” shall mean any weights over Secondary weights on Municipal Roads.

For the purpose of this policy, “per day” shall mean a 24-hour period, and “yearly” shall mean a calendar year of January 1st to December 31st of the current year.

2.0 Policy

The Rural Municipality of Leask No. 464 will charge fees for Overweight Permits within in the boundaries of the RM of Leask No. 464.

The annual tender for the RM gravel program shall be exempt from all fees relating to the program.

Farmers hauling farm commodities shall abide with “Overweight Restriction “during Spring Road Bans.

These permits will be issued as needed by Administration.

2.1 Fees for Overweight Permits in the RM are as follows:

Single Load	\$50.00 per unit
Single Load During Spring Restrictions	\$100.00 per Unit
Yearly Permit	\$300.00 per unit

2.2 That speed limits for the Municipal Roads be reduced to Sixty (60) Kilometer per hour.

2.3 That permits are subject to road ban restrictions and road conditions as set out by the Municipality, Bylaw 17-2023 or by the Ministry of Highways.

2.4 Owner of the permit is responsible to meet vehicle equipment regulations standards.

2.5 That the Vehicle must be register with SGI for the gross weight of the public highway.

2.6 No permit shall be issued without the payment of appropriate fees to the Municipality.

2.7 In the case of the Administrator not being in the office, this issuance of these permits shall default to the Assistant Administrator.
